 - 1. I am the Corporate Secretary and Corporate Information Officer of **Alphaland Corporation** (the "Corporation"), a corporation duly organized and existing under the laws of the Republic of the Philippines;
 - 2. On 1 March 1, 2013, the Corporation received a letter from the Capital Markets Integrity Corporation ("CMIC") of the Philippine Stock Exchange (the "Exchange") requiring the Corporation to submit a written statement under oath, in conformity with Articles XI-A, Section 5 of the CMIC Rules, confirming the existence or absence of any undisclosed information that could have triggered the unusual price movement of the Corporation's shares being traded in the Exchange;
 - 3. The Corporation is not aware of any undisclosed information could have triggered the observed unusual price movement;
